MORNING REPORT

Today's economic developments and market movements.

Key themes

President Trump indicated he may withdraw from the region without a plan to reopen the Strait of Hormuz, advising other nations to “go to the Strait and just take it” if they require oil.

Iran's President stated that Iran has “the necessary will to end this war”, but only if there are guarantees to prevent future aggression, rising hopes that both sides might be looking for a way to end the conflict.

The US equity markets rallied, with the S&P500 jumping almost 3% higher. Most major government bonds made significant gains. The DXY retreated 0.7%, but still recorded a 2.3% gain in March.

Australian government bond yields traded 5–11bp lower, as the market caught up with sharp global moves from the previous day. The AUD strengthened by 0.7%, though it still marked a depreciation by more than 3% in March.

Financial Markets

Ongoing uncertainty regarding the progression of the conflict in the Middle East continues to drive fluctuations in financial markets. President Trump indicated he may withdraw from the region without a plan to reopen the Strait of Hormuz, advising other nations to “go to the Strait and just take it” if they need oil.

News from Iran raised hopes that the war may conclude sooner rather than later if both sides agree to de-escalate. Reports indicated that Iran's President Masoud Pezeshkian, speaking with European Council President Antonio Costa, stated that Iran has “the necessary will to end this war”, but only if there are guarantees to prevent future aggression. However, it is still unclear whether this reflects a change in Iran's stance, as their previous conditions for ending the war remain unchanged.

- US equity markets rallied, with the S&P500 surging nearly 3% and most major sectors reporting notable gains. Despite this upswing, the index remained 5% lower since the onset of the war. Trading ahead of the latest headlines, movements in other major markets were more subdued. The Euro Stoxx 50 and the FTSE 100 both advanced 0.5%. Asian stocks were mixed – the Nikkei 225 dropped 1.3%, while the Hang Seng was little changed. The domestic ASX200 edged up 0.2%, ending a three-day streak of negative returns.
- Most major government bonds made gains. US Treasury yields declined by 4–5bp, with smaller moves in the super-long maturities. Other major government bonds traded in a similar fashion, with Gilt and Bund 10Y yields dropping by 2bp and 4bp respectively. The latter was supported by euro area inflation rising slightly less than anticipated. Australian government bond yields also traded 5–11bp lower, as the market caught up with sharp global moves from the previous day. Futures point to further yield compression today.
- In the FX space, risk-on sentiment allowed the DXY to retreat. It was down 0.7%, falling back below 100. However, it still ended the month 2.3% higher. Other major currencies appreciated – the EUR gained 0.8%, the GBP rose 0.3%. The AUD strengthened by 0.7%, though it marked a depreciation by more than 3% in March.
- Oil prices responded positively to the latest headlines regarding the Middle East conflict. The May WTI contract slipped 1.1%, while the Brent future for June eased \$4 to \$103.4. The risk-on tone and a weaker USD saw gold jump 3.5%. Iron ore eased 0.7%.

International Data

The flash estimate for **euro area HICP inflation** in March provided early insight into the inflationary effects stemming from the Middle East conflict. Consumer prices surged 1.2%*month* – the sharpest monthly increase since October 2022

– leaving the annual growth rate rising from 1.9%*yr* to 2.5%*yr*, slightly below consensus and ECB forecasts. Core inflation eased marginally to 2.3%*yr*, with declines in both core goods and services categories. Food inflation also edged lower, so the headline increase was entirely due to higher energy inflation which jumped from -3.1% *yr* to 4.9%*yr*.

As the average US petrol price exceeded \$4 a gallon for the first time since August 2022, the **Conference Board Consumer Sentiment Survey** suggested US consumers remain relatively resilient amid global shocks. The headline index rose by 0.8 in March to a three-month high of 91.8, though still below last year's and long-term averages. Consumers' assessment of present conditions improved, but expectations for the future declined, falling below the six-month average.

JOLTS data pointed towards softening labour market conditions in the US. **Job openings** fell from an upwardly revised 7.24mn in January to 6.88mn in February, below the six-month average of around 7mn. The ratio of job openings to unemployment – a key measure of labour market slack watched by the Fed – declined from 0.98 to 0.91, well below last year's average, indicating increasing slack in the labour market.

China's official NBS PMIs indicated that economic momentum in the world's second largest economy strengthened towards the end of Q1. The composite PMI increased by 1pt to 50.5. This improvement was primarily driven by the manufacturing sector – its PMI rose by 1.4pt to a twelve-month high of 50.4.

Local Data

Higher-than-assumed commodity prices are expected to deliver the **Australian Federal budget** a windfall of almost \$60bn over the five years - [we published our analysis here](#).

Australia's private sector credit growth picked up in February, rising from 0.5 to 0.6%*month*, consistent with both our expectations and the consensus. Year-ended growth also edged higher to 7.8%*yr* ([see here](#)).

NZ Business confidence understandably fell in March, particularly later in the month as the consequences of the Middle East conflict for New Zealand became more apparent ([see here](#)).
