MORNING REPORT

Today's economic developments and market movements.

Key themes

President Trump sought to maintain maximum pressure on Iran, continuing to suggest that strikes were imminent if the US did not receive “100% good answers” from Tehran.

Oil prices declined and other major markets rallied, as investors took comfort from headlines citing Trump saying the US was in the “final stages” with Iran.

Hopes of a peace deal in the Middle East and lower oil prices lifted equity valuations, with the S&P 500 gaining more than 1% and snapping a three-day losing streak.

The minutes from the latest FOMC meeting confirmed that the balance of views within the Committee is becoming more hawkish.

The US Treasury curve shifted around 6 – 8bp lower, Gilts outperformed, reacting to a significant CPI inflation miss in the UK.

Financial Markets

Financial markets remained volatile as they tried to assess which direction the Middle East conflict was most likely to take – further escalation, with the US resuming its military campaign, or a diplomatic breakthrough towards a peace deal. In his usual style, President Trump sought to maintain maximum pressure on Iran, continuing to suggest that strikes were imminent if the US did not receive “100% good answers” from Tehran. In the end, oil prices declined and other major markets rallied, with the S&P 500 finishing the day in the green and most major government bonds posting notable gains, as investors took comfort from headlines citing Trump saying the US was in the “final stages” with Iran.

In terms of the economic news flow, the minutes from the latest FOMC meeting confirmed that the balance of views within the Committee is becoming more hawkish. Meanwhile, the weaker-than-expected CPI print in the UK suggested there is no urgency for the BoE to increase Bank Rate.

- Hopes of a peace deal in the Middle East and lower oil prices lifted equity valuations, with the S&P 500 gaining more than 1% and snapping a three-day losing streak. Tech stocks and consumer discretionary names posted the strongest gains, while energy stocks fell 2.6%. In Europe, the Euro Stoxx 50 rallied more than 2%, while the FTSE 100 in the UK gained 1.0%. Asian and Australian equities, which traded ahead of the latest news, were mostly in the red. The ASX finished the day down 1.3%.
- Bond markets rebounded, trimming the losses seen in recent days, as lower oil prices helped ease some concerns about spiralling inflation across major economies. The US Treasury curve shifted around 6 – 8bp lower, with the 10Y yield down 8bp to 4.59%, though still around 10bp higher than a week earlier. Gilts outperformed, reacting to a significant CPI inflation miss in the UK. The 10Y Gilt yield fell 14bp to move back below 5%. Bund yields were around 10bp lower at the short end, with somewhat smaller moves at the very long end. Aussie yields finished the day 1bp higher, but futures suggest a strong rally at the market open this morning, as valuations catch up with the global moves.
- In FX markets, the DXY index lost 0.2%. Major European currencies took the opportunity to recoup some of the previous day’s losses – the EUR was 0.2% stronger, while the GBP gained 0.3%. Meanwhile, the yen strengthened by only 0.1%. The AUD outperformed, appreciating 0.6% to 0.7154 and paring the prior day’s losses.
- Oil prices fell following Trump’s comments on progress in negotiations with Iran. The July WTI contract declined by around \$6 to 98.3, while the equivalent Brent contract fell to \$105.3 from around \$111.0 the previous day. Gold rallied

1.4%, while copper also posted gains, rising 1.8%.

International Data

The minutes of the April FOMC meeting were primarily focused on the outlook and risks for inflation. There was a lengthy discussion of potential upside risks to inflation in coming months, with escalation in the Middle East, its direct and indirect effects on prices globally, US tariffs and the strength of AI infrastructure investment all seen as potential upside risks to US consumer inflation. “The vast majority of participants noted an increased risk that inflation would take longer to return to the Committee’s 2 percent objective.”

In contrast, participants were sanguine on the labour market, assessing there to be balance between labour demand and supply, and limited downside risks. GDP growth was also expected to be solid this year, the staff forecasting momentum to hold just above trend.

On the policy stance, “a majority of participants highlighted, however, that some policy firming would likely become appropriate if inflation were to continue to run persistently above 2 percent.”

Euro area HICP final inflation print for April was fully aligned with the flash estimate, confirming a 1.0%_{mth} increase and lifting annual inflation from 2.6%_{yr} to 3.0%_{yr}. Core inflation was also unchanged from the initial reading at 2.2%_{yr}, though this still marked a modest decline from 2.3%_{yr} in March.

In the UK, strong base effects were always expected to push annual **CPI inflation** materially lower in April. However, rising energy prices tempered expectations for the decline, with both market consensus and the BoE forecasting a drop from 3.3%_{yr} to 3.0%_{yr}. The incoming CPI print surprised notably to the downside at 2.8%_{yr}, with core inflation easing to 2.5%_{yr}. Fuel prices surged by more than 14%_{mth}, but the impact on the overall energy category was offset by regulated household energy prices, which fell 7.0%_{mth}. The softer inflation outcome, alongside the latest jobs data pointing to further easing in the UK labour market, are likely to alleviate concerns at the BoE over the need to raise rates immediately.
