MORNING REPORT

Today's economic developments and market movements.

Key themes

All eyes on Friday were on Kevin Warsh's first address to the Jackson Hole Symposium. His comments indicated willingness to act in order to bring US inflation back to the Fed's target.

Following the speech, the fed funds futures curve repriced the probability of a hike at the next FOMC meeting on 16 September from around a third to more than a half. US Treasuries sold off sharply.

The September FOMC decision will depend on the economic data flow before the policy meeting, including this Friday's US labour market data for August, where payrolls are expected to bounce back by 55k (Westpac forecast 70k) after a 23k drop in July.

In Australia this week, the June quarter National Accounts on Wednesday, and the partial indicators leading up to them, will take centre stage. We expect GDP to increase by 0.2%qtr.

Financial Markets

All eyes on Friday were on Kevin Warsh's first address to the Jackson Hole Symposium. The Fed Chair used the opportunity to emphasise the Fed's commitment to its 2% price stability objective and maximum employment, before assessing the current state of the US economy. Most attention was on his concluding comments, where he made clear that the Committee "must be confident that underlying inflation is moving to our objective, clearly and at sufficient speed". "Otherwise, we have work to do." – suggesting where the FOMC's assessment of risks lay and its willingness to act

- Results across major equity markets on Friday were mixed. The S&P500 lost 0.2% on the back of higher interest rate expectations, and as the tech sector pared back the optimism seen after NVIDIA's earnings announcement earlier last week. European stocks, trading ahead of Warsh's speech, made gains across the board, with the Euro Stoxx 50 up 0.9%. Japanese stocks also gained, while Chinese markets were lower and the South Korean Kospi fell 1.8%. Meanwhile, the Australian ASX 200 was up 0.6%, paring losses from the prior two days.
- US Treasuries sold off sharply following Warsh's comments. The front end of the yield curve jumped by 11–12bp. The 10Y yield rose 4bp to 4.72%, close to the top of its recent range. Other major government bonds followed suit, with 10Y Bund, Gilt and JGB yields all 3bp higher. Aussie yields eased slightly at the front end on Friday, but futures are pointing to an increase at the market open today as local markets catch up with global trends.
- In currency markets, the DXY appreciated 0.5%, its biggest one-day gain since mid-June. Other major currencies lost ground – the EUR was down 0.6%, while GBP and JPY depreciated by 0.4%. The AUD followed a similar pattern, also down 0.4% to 0.7157.
- In commodity markets, crude was little changed, with Brent and WTI trading at \$89.3 and \$83.4 respectively. News headlines suggested the additional US sanctions announced against Iran at the beginning of last week has had little impact, while comments from Iran's President over the

weekend struck a more constructive tone and suggested more willingness to make compromises in the conflict with the US. "Taking an all-or-nothing approach will not yield results," he said. Over the weekend, crude markets were also digesting President Trump's announcement that the US had reached a deal with Venezuela to take majority control of its oil reserves. In other markets, higher US yields pulled gold prices lower, down more than 3%.

International Data

US University of Michigan consumer sentiment was little changed in the final estimate for August at 51.7, up slightly from the prior month but still near the historic low for the series. Current conditions and expectations both remained abnormally weak, despite an improvement in near-term inflation expectations. The one-year indicator stepped back from 4.4%yr to 4.0%yr, while five-year expectations were unchanged at 3.3%yr – a benign rate relative to the history of the series.

The US Bureau of Labour Statistics announced a preliminary benchmark revision for historical nonfarm payrolls data. As at March 2026, the level was revised 79k lower. This contrasted with the market's expectation for a positive net revision of 183k, but was only a fraction of the prior year's -911k revision. Unlike in 2025, nonfarm payrolls in 2026 have experienced steady downward revisions to the prior two months, limiting the scope for a large downward revision. The final estimate will be published in early 2027.

The European Commission economic confidence edged up from 97.1 in July to 98.4 in August, the highest level since the start of the year, suggesting improving euro area economic momentum this quarter. Consumer confidence, meanwhile, was confirmed at -15.5, up 0.4pts from the prior month and 5pts from the trough in April, broadly in line with its five-year average.
